LOCATION, ACCESS & USE

- The End of Trip facility is located on Upper Car Park Level (B2).
- Bikes enter One William Street off Mounts Bay Road and arrive at Upper Car Park Level ('B2') via the vehicle ramp.
- Pedestrian access is via the Car Park Shuttle Lift or Goods Lift (Press level 'B2' button).
- Riders should use the 'green' cycle-ways in the car park and dismount close to the entry to the End of Trip facility.
- Riding inside of the End of Trip facility is not permitted.
- Cycling shoes and cleats should be removed before exiting the End of Trip facility.
- Bike locks are not to be stored on the bike racks when not in use.
- Authorised Users must ensure the bike repair stand is used in a safe manner and left in a clean and tidy condition at all times.
- Authorised Users may access the bike storage area at any time (24/7) via access pass.
- The main car-park roller door is opened at 7.00 am and closed at 8.00 pm, Monday to Friday.
- Riders may use their access card at the car park entry/exit for egress outside of these hours.
- Any items found in open lockers/change areas will be removed, stored for 30 -days and suitably disposed of thereafter.
- Authorised Users are expected to behave in a courteous manner and leave the amenities in the condition they would expect to find them.
- The End of Trip facility includes the latest energy and water efficient devices. Authorised Users should keep shower times to a minimum.
- Authorised Users must ensure safe use of the iron, hair -dryers and straighteners.
 When finished with, these items should be placed back in position and switched off.

- Your One William Street building access card will also allow access to the End of Trip facility.
- Access is restricted to Authorised Users only. An Authorised Users is an employee of a tenant or occupant of One William Street, Perth.

- All Authorised Users must vacate the End of Trip facility immediately on activation of the fire alarm.
- All Authorised Users must comply with all reasonable directions provided by One William Street Management.
- Authorised Users not abiding by the General Rules may have their access privileges revoked at the sole discretion of One William Street Management personnel.
